Hello everyone! I wanted to take a moment to introduce myself. My name is JanRose Ottaway Martin, and I started as the new Executive Director at North Sound BHASO in September of this year. I have an extensive background in both direct behavioral health practice and behavioral health administration. I worked for several years in the mental health outpatient program at Downtown Emergency Services Center in Seattle as a case manager and then a supervisor specializing in the homeless populations with the most acute and chronic mental health and substance use disorders. After that, I worked for King County in the Department of Community and Human Services (DCHS) Behavioral Health and Recovery Division (BHRD). I held multiple positions while at BHRD, with my most recent being Business Operations Manager where I worked extensively with the Medicaid-, Mental Illness Drug Dependency tax (MIDD)-, and BHASO-funded programs. I have an undergraduate degree in Sociology from Western Washington University and a Masters in Social Work from the University of Washington.

While the majority of my work experience has been in King County, I was born and raised in the North Sound region and continue to live in Snohomish County. Additionally, I come to this work with a lived history of poverty and my own experience with rural homelessness as a youth. I am passionate about helping those with little financial resources access support and health systems when and how they need them the most. Personally, I am an avid traveler, have three dogs who keep me busy, enjoy live arts (theater, concerts), hiking, and volunteer extensively in the community.

I have focused heavily in my first few months on meeting and making new connections in the North Sound region with providers, stakeholders, government officials and local politicians, as well as getting to know the staff, workflow, and processes at North Sound BHASO. NEW CHILD, YOUTH AND FAMILY MOBILE OUTREACH TEAM SERVES WHATCOM AND SKAGIT COUNTIES

The Child, Youth, and Family Crisis Team (CYFCT) is a voluntary outreach team with the ability to respond and provide crisis and stabilization services in the community (e.g., homes, schools, shelters, juvenile courts, etc.). The team serves children, youth, and families who are navigating a behavioral health (mental health and/or substance use) crisis regardless of what type of health insurance they have. CYFCT offers short term crisis intervention and stabilization services for up to eight weeks utilizing strengths-based, solution-focused, culturally sensitive, trauma-informed, and recovery-oriented interventions.

CYFCT is made up of a group of behavioral health professionals who collaborate with the family to develop a strategy for getting through the current distress and helping them find tools and connections to resources that will help them manage future crises and move towards recovery. Peer counselors draw on their own experiences to help youth and families find hope and support their recovery. The peer's own life experience uniquely equips them to provide support, encouragement, and resources in ways other professionals cannot. Care coordinators work to create connections

between families and system partners so that the family is supported in their efforts to find stability and the resources they need to manage future events. Finally, mental health professionals help children, youth, and families better understand and cope with thoughts, feelings, and behaviors that cause distress.

Anyone under 21 years old who is physically located in Skagit or Whatcom County is eligible. Whether the situation is a full-blown crisis, or the youth or family is trying to keep a situation from getting more unmanageable, CYFCT provides an intervention that is designed to help young people and their families navigate behavioral health challenges so that they can move toward recovery and a sense of overall well-being.

- Care coordination and safety planning
- Care planning services and stabilization for up to 8 weeks
- Community outreach; meeting children, youth, and families where they are
- Referrals to community resources
- Identification of natural supports
- Peer support for both young people and family members

Currently, the team's hours of operation are 9-5, Monday – Friday. If the team is needed outside of those hours, the Mobile Crisis Outreach Team (MCOT) will respond and transfer the case over to CYFCT as soon as possible. That way, children, youth, and families can receive the benefit of CYFCT's specialized services regardless of when they initially reached out. Services may be accessed by calling (800) 584-3578 anytime, night or day.

HOMELESS OUTREACH STABLIZATION AND TRANSITION (HOST) PROGRAM CELEBRATES ONE YEAR

Evergreen Recovery Centers HOST program celebrated one year of service in Snohomish County, serving over 100 clients since November 2022, there have been 1644 encounters with an average time spent with a client during an encounter of 90 minutes. 318 Naloxone kits were distributed between May and October of 2023.

RECOVERY NAVIGATOR PROGRAM CELEBRATES ONE YEAR

The Recovery Navigator Program in the North Sound Region has reached the one-year mark since implementation. In collaboration with law enforcement, co-responders, service providers, social contacts, housing programs, and community-based programs we've helped to stabilize and assist hundreds of individuals in the community. With ongoing outreach and engagement, the plan for this coming year is to broaden our network of resources and connections throughout the North Sound Region.

OPIOID ABATEMENT COUNCIL (OAC) UPDATE

As part of the One Washington Memorandum of Understanding (MOU) between Washington Municipalities, local governments participating in the Opioid settlement fund allocation process had to establish local Opioid Abatement Councils. Our region selected North Sound BHASO to oversee the North Sound Regional OAC. The purpose of the regional OAC is to provide public accountability and transparency, monitor distribution of Opioid Funds to programs and services within the region for "Approved Purposes" (as identified in the One Washington MOU), develop a centralized public dashboard or other repository for the publication of expenditure data of Opioid Funds, require and collect additional outcome-related data to evaluate use of Opioid funds if necessary, and hear complaints by Participating Local Governments. While North Sound oversees the North Sound Regional OAC, other members of the OAC include one representative from each of the 5 counties, and one representative per county for all cities in that county. We have held two meetings so far (October 5th and December 8th). Regionally, most participating governments are just starting to receive funds and are identifying how they will utilize those funds. We look forward to bringing further updates in the future as this body of work moves forward.

ASSISTED OUTPATIENT TREATMENT (AOT) PROGRAM

North Sound Behavioral Health Administrative Services Organization (North Sound BH-ASO) is pleased to announce that we have formally partnered with the Behavioral Health Agency, Conquer Addictions to implement an Assisted Outpatient Treatment (AOT) program in Snohomish County. The AOT program will provide court mandated Less Restrictive Alternative (LRA) treatment to high-needs individuals with necessary mental health and substance use treatment without necessitating hospitalization with an aim to better motivate an individual who struggles with voluntary treatment adherence to engage fully with their treatment plan. The program is currently in the hiring stages with a target of beginning serving AOT orders in early 2024. Snohomish County Courts as well as county stakeholders and providers have been working closely with North Sound BH-ASO and Conquer to prepare for this implementation. Re: Required Centers for Medicare & Medicaid Services (CMS) Trainings Due December 1, 2023

Dear North Sound Behavioral Health Administrative Services Organization (North Sound BH-ASO) Contracted Providers:

As stipulated in North Sound BH-ASO contracts with the five (5) managed care organizations (MCOs), all contracted providers are required to complete the following Medicaid Fraud, Waste and Abuse trainings:

- Combatting Medicare Parts C and D Fraud, Waste and Abuse Training

North Sound BH-ASO will provide information on how to access the approved webbased training provided by Centers for Medicare & Medicaid Services (CMS). **If your organization intends to use a different training, it must submit a copy of the training materials to North Sound BH-ASO for our records**. A copy of the training may be submitted via email to <u>compliance_officer@nsbhaso.org</u>.

Each provider will need to complete an annual attestation form that provides evidence that all employees and downstream entities (sub-contractors) that provide health care or administrative services for North Sound BH-ASO members at or on behalf of the provider organization have completed, or will complete, the above training. Completed attestations may be submitted via email to <u>compliance_officer@nsbhaso.org</u>.
