RECOVERY NAVIGATOR PROGRAM

North Sound BH-ASO will be implementing Recovery Navigator Programs in the North Sound region. Each program will collaborate with law enforcement to provide an alternative to incarceration. The program will consist of Case Managers and Recovery Navigators that provide appropriate, long-term intensive case management and recovery services to youth and adults with substance use disorder (SUD), including persons with co-occurring substance use disorders and mental health conditions, who are referred to the program. LETTERS OF INTEREST – COMMUNITY BEHAVIORAL HEALTH RENTAL ASSISTANCE (CBRA) PROGRAM

The North Sound BH-ASO is soliciting Letters of Interest to contract with the BH-ASO to provide services under the "Community Behavioral Health Rental Assistance Program" (CBRA).

The 2021 Legislative Session provided a significant increase in funds to provide permanent rental subsidy for high-risk individuals with behavioral health conditions and their households. The Department of Commerce (DOC) has contracted with the North Sound BH-ASO to serve as the lead grantee for the North Sound region. The North Sound BH-ASO is seeking to contract with nonprofit housing assistance organizations or other behavioral health organizations who provide housing support services to provide Permanent Housing Subsidies to eligible persons in one or more counties in the North Sound region.

WORKFORCE DEVELOPMENT STRATEGIES

The North Sound BH-ASO continues to work with the Mangaged Care Organizations (MCOs) and Health Care Authority (HCA) to develop and fund strategies to help behavioral health agencies with workforce recruitment and retention. HCA staff are developing a plan to implement some of the

recommendations in the report from the state Health Workforce Council-Behavioral Health Group.

HCA staff will also be meeting with the Administrative Service Organizations (ASOs) and MCOs to identify strategies where we can supplement state efforts with our own funding investments. In the meantime, we will be sending out a survey to our Behavioral Health Agecy (BHA) network to solicit uses for Behavioral Health Enhancement and COVID Supplemental Federal Block Grant funds. We want to be intentional about using the funds by aligning our workforce strategies withthe state plan. We expect to release the survey mid-September.
