Call to Order and Introductions - Chair Johnson

The Chair called the meeting to order and initiated introductions via GoToMeeting

Revisions to the Agenda - Chair

It was noted that the Proclamation from the Governor regarding the Open Public Meetings Act was extended to September 1st making allowance for virtual board meetings to continue to take place due to COVID.

Approval of the June 11th, 2020, Minutes, Motion #20-33 – Chair Johnson

Bill Watson moved approval of the motion and Cammy Hart-Anderson seconded, all in favor, none opposed, motion #20-33 carried.

Comments & Announcements from the Chair

The Chair noted that the Island County Stabilization Center is almost finished. She added that tours can be scheduled for anyone interested. She added that Pioneer will be running the Center.

Reports from Members

- Anne Deacon, Whatcom County, said that the Whatcom County Stabilization Center is now projected to open around the 1st of November.
- Cammy Hart-Anderson, Snohomish County, said the Community COVID Outreach Counselor Program made contact with 382 individuals in the past month. The project is funded by CARES Act dollars and was mentioned in the paper.

She added that another program funded by CARES Act dollars (Psychological First Aid Training) is being contracted through Compass and 5 of the 8 currently scheduled sessions are sold out.

Cammy also mentioned that the Behavioral Health Capital Project is on track and going well. Occupancy is expected July 1st, 2021.

Report from the Advisory Board

Pat O'Maley Lanphear, Advisory Board Chair, gave a brief on the Report from the Advisory Board and referenced the following topics:

- Questions will be developed for the Managed Care Organizations (MCOs). The goal is collaborative dialogue sessions with the North Sound BH-ASO Advisory Board.

Report from the Executive Director

Joe gave a briefing on the Action Item below, Motion #20-35, and referenced the Memo that was sent to the Board Members prior to the meeting. The Lease Cost Comparison Spreadsheet was referenced, and the monthly cost savings were noted, in addition to the purpose of downsizing the North Sound BH-ASO office space.

Brad Furlong (North Sound BH-ASO Counsel) spoke about the various aspects of the proposed lease.

A Board Member asked if a shorter lease could be considered, which would reduce potential liability.

Brad noted that he would draft up language for a possible shorter lease for the landlord to consider.

Costs being covered under the 5-year term were discussed, versus amortizing the costs under a 3-year lease.

Joe said the lease will be coming back to Board in September for a decision with cost detail.

Valley Mall Way Lease...... Attachment

After reviewing the cost comparisons and future business needs it became evident that the most prudent option is to terminate the lease at 301 Valley Mall Way, Ste. 110. A certified letter of intent was sent to the landlord on July 24, 2020. The notice of termination will be sent with Board of Director Approval.

Motion #20-35

The North Sound BH-ASO Executive Director has the authority to provide a termination notification to Pacific NW Properties for the lease on 301 Valley Mall Way, Ste. 110 and to negotiate with Windemere Commercial Real Estate on a five (5) year lease for the property at 2021 E. College Way, Mount Vernon, WA. 98273.

Cammy Hart-Anderson proposed an amendment to the motion that there would be exploration on early-out options from the 5-year lease. Rud Browne seconded the motion. All in favor of the motion as amended, none opposed, no abstentions, motion #20-35 carried as amended.

Summary:

Whatcom County Triage

Whatcom County and the two providers, Pioneer Human Services (PHS) a substance use provider and Compass Health a mental health provider have requested startup funding for the new triage center. The proviso funding of \$500,000 annually is designated for services to Non-Medicaid individuals and not for startup costs. North Sound evaluated the two requests and determined the following amounts were appropriate for facility startup needs. These funds are General Fund-Sate (GF-S).

- PHS will receive \$205,452 for startup costs
- Compass Health will receive \$143,750 for startup costs

Motion #20-36

North Sound BH-ASO-PHS-ICN-19-20 Amendment 5 to provide funding in the amount of \$205,452 for startup costs at the Whatcom Triage facility. The contract term of the contract is July 1, 2019 through June 30, 2021 with an automatic one-year renewal on July 1, 2021 based on continued compliance with the terms of the contract.

Ken Dahlstedt moved the motion for approval, Cammy Hart-Anderson seconded, all in favor, none opposed, no abstentions, motion # 20-36 carried

North Sound BH-ASO-Compass Health-ICCN-19-20 Amendment 5 to provide funding in the amount of \$143,750 for startup costs at the Whatcom Triage facility. The contract term of the contract is July 1, 2019 through June 30, 2021 with an automatic one-year renewal on July 1, 2021 based on continued compliance with the terms of the contract

Update of North Sound BH-ASO Statement of Mission, Vision, and Values

The North Sound BH-ASO's contract with the Health Care Authority requires us to review all policies and update them as necessary on an annual basis. Policy #1011.00 established the "North Sound BH-ASO Mission, Vision, and Values". These were the same Mission, Vision, and Values that had been developed by the BHO. The new HCA contract requirements for BH-ASOs added new requirements for the BH-ASOs to demonstrate "cultural humility" and to develop systems of care that are "culturally appropriate". Given the awakened awareness of systemic racism and its impact on health, and to incorporate the new HCA contract requirements, we are proposing to update our Mission, Vision and Values, by making the following changes:

- **Culture:** We endeavor to <u>cultivate cultural humility in attempting to understand the world view of the persons and <u>communities we serve.</u></u>
- Social Equity: We commit to working to reduce institutionalized racism and reduce related disparities in health care.

Motion #20-38

Approve the revised Policy #1011, Mission, Vision, and Values.

Bill Watson moved the motion for approval, Cammy Hart-Anderson seconded the motion, all in favor, none opposed, no abstentions, all in favor, motion #20-38 carried
