North Sound BH-ASO Chair and Vice Chair

Summary:

The motions listed below are for the new BH-ASO Board of Directors Chair and Vice Chair. The nominations received as of June 5 from Board Members for Chair and Vice Chair are below:

- Chair: Jill Johnson and Ken Dahlstedt
- Vice-Chair: Rud Browne and Bill Watson

During the pandemic, the Governor issued a temporary Proclamation pertaining to the Open Public Meeting Act (OPMA) regarding the allowance of virtual meetings in lieu of in-person meetings to carry out necessary action.

NS BH-ASO will be using an electronic voting application during the tele-conference meeting by sending two voting ballots to each voting member participating in the June 11^{th} , 2020 Board of Directors meeting via GoToMeeting. One voting ballot will be for Chair and one for Vice-Chair.

Prior to sending the email, Board Members will announce if they are voting for their county in accordance to the total number of votes allowed for each county, per the Interlocal Agreement. Voting will take place through the emailed ballot link which can be accessed and engaged via computer, tablet, or smart phone.

North Sound BH-ASO IT/IS Manager will send out the electronic ballot via email to each *voting member*. The Clerk of the Board will display the results on the computer screen via the teleconference meeting, as well as make the announcement of the newly elected Chair and Vice-Chair.

The nominees for Chair and Vice Chair spoke of their interest and qualifications in for the Board of Directors Chair and Vice Chair positions. Ken and Jill spoke about their interest and qualifications in the role of Chair. Bill and Rud spoke about their interest and qualifications for the role of Vice Chair.

Motion #20-20

To approve the results of the electronic election voting process for the Chair of the North Sound Board of Directors based on the candidate who receives the most votes which will be displayed and announced by the Clerk of the Board.

There were issues with the electronic voting process and the number of votes received. Sam Low moved a motion for approval that Jill Johnson would be Chair until the end of the year and that Ken Dahlstedt would be Chair beginning in January 2021; Bill Watson seconded the motion, all in favor, none opposed, no abstentions, motion #20-20 carried with the revised language.

Motion #20-21

To approve the results of the electronic election voting process for the Vice-Chair of the North Sound Board of Directors based on the candidate who receives the most votes which will be displayed and announced by the Clerk of the Board.

Sam Low moved the motion for approval that Rud Browne would be the Vice-Chair until the end of the calendar year 2021. Anne Watson seconded the motion, all in favor, no nays, no abstentions, motion #20-21 carried.

Funding amounts are currently unavailable. We anticipate our HCA contract within the next two weeks. Once the contract and funding documents are received, we will develop the budgets for the contracts listed for approval.

Health Care Authority

Summary:

The North Sound contract with HCA provides funding for Crisis Services, Legislative Provisos, Substance Abuse Block Grant and other non-Medicaid services within available resources.

Motion #20-22

Health Care Authority-North Sound BH-ASO-20 providing funding for the period of July 1, 2020 through December 31, 2020.

Ken Dahlstedt moved the motion for approval, Rud Browne seconded, all in favor, none opposed, motion #20-22 carried

Triage Facilities/Crisis Centers/Withdrawal Management

Summary:

Triage and Crisis Facilities serve several Non-Medicaid individuals throughout the year without payment for their treatment. We recently funded the 2019-2020 shortfalls for the Snohomish and Skagit County facilities and propose to extend the funding through the next fiscal year.

Lynnwood Detox is an acute withdrawal management facility operated by Evergreen Recovery Centers in Snohomish County. Evergreen is the only provider in our region to provide this level of care.

As with the 2019-2020 contract amendments, the funding will be based on projected monthly operational costs divided by the number of Non-Medicaid individuals projected to be served multiplied by the number of projected bed days for a month. We are still waiting for the final cost projections from the providers.

Peer Bridger Mental Health Block Grant

Summary:

Telecare Corp. provides Peer Bridger services for individuals discharging from Western State Hospital or Community Psychiatric Hospitals. The service is providing by Peers, reintegrating the individuals back into the community and supporting them in their recovery. This is a regional service.

Motion #20-26

North Sound BH-ASO-Telecare-MHBG-20-21 providing a budget for the period of July 1, 2020 through December 31, 2020. The contract term of the contract is July 1, 2020 through June 30, 2021 with an automatic one-year renewal on July 1, 2021 based on continued compliance with the terms of the contract.

Family Haven Mental Health Block Grant

Summary:

Family Haven is a program of the Tulalip Tribes providing outreach to at-risk youth who are homeless and in need of support and treatment.

North Sound BH-ASO-Family Haven-MHBG-20-21 providing a budget for the period of July 1, 2020 through December 31, 2020. The contract term of the contract is July 1, 2020 through June 30, 2021 with an automatic one-year renewal on July 1, 2021 based on continued compliance with the terms of the contract.

Cammy asked if the ASO could reach out to the Stillaguamish Tribe and see if there is a way the ASO could expand some of the things that are working well.

Pregnant and Parenting Women Housing Supports-Substance Abuse Block Grant

Summary:

These amendments with Brigid Collins, Catholic Community Services NW (CCS NW) and Evergreen Recovery Services provide funding for the period of July 1, 2020 through December 31, 2020. Services are provided to women who have discharged from Substance Use Treatment and in need of additional support once housed, such as housing case management.

Snohomish County Juvenile Treatment Services

Summary:

This contract provides treatment for youth involved in the criminal justice system for the period of January 1, 2020 through December 31, 2020.

Motion #20-29

North Sound BH-ASO-Snohomish County Superior Court-20 to provide treatment services to youth involved in the criminal justice system. The contract term of the contract is January 1, 2020 through December 31, 2020 with an automatic one-year renewal on January 1, 2021 based on continued compliance with the terms of the contract.

Bill Watson moved the motion for approval, Ken Dahlstedt seconded the motion, Cammy Hart Anderson abstained, Sam Low abstained, Nicole Gorle abstained. Motion #20-29 carried by majority vote with a contingency:

Margaret was asked to reach out to the State and get a more thorough understanding of the Juvenile Court specifications and details.

Getting caught up in an audit situation was one of the concerns of Snohomish. It was noted that the motion is contingent upon the requirements being compliant with the state, and in agreement with Snohomish County.

Regional Ombuds Services

Summary:

This amendment provides funding for the period of July 1, 2020 through December 31, 2020 for regional Ombuds Services. A portion of the costs are covered by the Managed Care Organizations for services provided to Medicaid members.

Motion #20-30

North Sound BH-ASO-Ombuds-20 Amendment 1 providing a budget for the period of July 1, 2020 through December 31, 2020. The contract term of the contract is January 1, 2020 through December 31, 2020 with an automatic one-year renewal on January 1, 2021 based on continued compliance with the terms of the contract.

Ken Dahlstedt moved approval of the motion, Rud Browne seconded, all in favor, none opposed, no abstentions, Motion # 20-30 carried

Integrated Care Network Contracts

Summary:

The Lake Whatcom Contract and the other provider contract amendments are adding the provision of Mental Health Outpatient/Intensive Outpatient Services. We stopped funding mental health services (other than crisis services) in July

1, 2019. These providers are the only providers credentialed with the ASO to provide mental health services in our region.

We anticipate the authorizations will commence as we let the providers know we have funding for the Non-Medicaid population. There is a need for individuals who are Medicare only or are uninsured. These contracts are fee for service, providers will be paid upon authorization and data submission.

Compass Health and Lake Whatcom Center will be contracted for Program for Assertive Community Treatment (PACT) slots, Compass Health for two in Skagit County and Lake Whatcom Center for one in Whatcom County in addition to outpatient services.

Motion #20-31

- North Sound BH-ASO-Compass Health-ICCN-19-20 Amendment 4 providing a budget for the provision of outpatient and intensive outpatient mental health services. The contract term of the contract is July 1, 2019 through June 30, 2020 with an automatic one-year renewal on July 1, 2020 based on continued compliance with the terms of the contract.
- North Sound BH-ASO-Sunrise Services-ICN-19-20 Amendment 1 providing a budget for the provision of mental health outpatient and intensive outpatient services. The contract term of the contract is July 1, 2019 through June 30, 2020 with an automatic one-year renewal on July 1, 2020 based on continued compliance with the terms of the contract.
- North Sound BH-ASO-Sea Mar Community Health Centers-ICN-19-20 Amendment 1 providing a budget for the provision of mental health outpatient and intensive outpatient services. The contract term of the contract is July 1, 2019 through June 30, 2020 with an automatic one-year renewal on July 1, 2020 based on continued compliance with the terms of the contract.
- North Sound BH-ASO-Lake Whatcom-ICN-19-20 providing a budget for the provision of mental health outpatient and intensive outpatient services. The contract term of the contract is July 1, 2019 through June 30, 2020 with an automatic one-year renewal on July 1, 2020 based on continued compliance with the terms of the contract

Jail Transition Services

Summary:

San Juan county is in the development of their Jail Transition project and was unable to launch prior to the end of the contract period. The County offered their funding of \$22,388.10 to the other four counties, Snohomish County decided to forgo the funding. The funding was distributed to the three counties. Upon agreement, the following funding is allocated as follows.

- o Island \$6,600
- o Skagit \$7,400
- o Whatcom \$8,388.10
