Motion #20-08

■ North Sound BH-ASO-CASC-SABG-19-20 Amendment 1 providing additional funds in the amount of \$50,000 for the six-month period. For a new maximum consideration of \$100,000 for the twelve-month period. The current term of the contract is July 1, 2019 through June 30, 2020.

Summary:

HARPS

Health Care Authority (HCA) offered an Amendment to the HARPS contract to add \$50,000 for Substance Use
Disorder housing subsidies for the Compass Health HARPS program in Snohomish County. These subsidies are
for individuals undergoing treatment for a substance use disorder and eligible for the HARPS program criteria.
This amendment came in prior to Compass Health notifying North Sound of their intent to terminate the HARPS
contract. We have a meeting on Tuesday, February 11th to discuss the next steps with HCA.

We had a conversation with HCA on 2/12 to discuss our options for the HARPS contract going forward. HCA is supportive of our keeping the contract with the understanding we will be seeking a new provider and suggested we look at the Foundational Community Support (FCS) providers in our region. FCS agencies provide supported employment and/or supported housing services. We will be reaching out to the FCS providers in our region to gauge interest, fortunately we have contracts with a number of the FCS providers.

Motion #20-09

Health Care Authority-North Sound BH-ASO-HARPS-19-20 Amendment 1 to provide an additional \$50,000 for SUD subsidies for the period of January 1, 2020-June 30, 2020. The new maximum consideration on this contract is \$566,440 with a current term of July 1, 2019 through June 30, 2020.

Regina Delahunt moved approval of the motion, Bill Watson seconded, all in favor, motion #20-09 carried
