Call to Order and Introductions - Vice-Chair Stephens

Vice Chair Stephens called the meeting to order and initiated introductions

Revisions to the Agenda - Vice Chair Stephens

Vice Chair Stephens asked if there were any revisions to the November Agenda, there were none

Approval of the October 11, 2018, Minutes, Motion #18-128 - Vice-Chair Stephens

Ken Dahlstedt moved the motion for approval, Regina Delahunt seconded, all in favor, motion #18-128 carried

Comments & Announcements from the Chair

The Vice Chair asked Betsy Kruse, North Sound BHO Deputy Director, to speak about the latest announcement from Health Care Authority (HCA) to move the start date out for the implementation of the Behavioral Health Services Organization (BH-ASO) to July 1st, 2019.

She noted the North Sound BHO agreed with the decision. This will allow more time for the Managed Care Organizations to prepare for integration through preparation of Provider Networks.

In addition, it would allow the State more time to prepare for the upcoming changes.

The Chair said this will affect some of the discussion today, as well as the dates on some of the motions.

Reports from Members (Vice-Chair Stephens)

 Cammy Hart-Anderson, Snohomish County, said Seattle Public Radio Station radio station KUOW has been exploring responses to the Opioid Epidemic (Finding Fixes) and working with Snohomish County.

Tonight, they will be rolling out their pod-cast which covers 5 areas:

- Expansion of Suboxone and Ideal Options coming into the Diversion Center
- Narcan
- Utilization of the Department of Emergency Management in response to the Opioid Epidemic (recognized as a county emergency crisis)
- Professional Handlers; (highlighting the work with the Human Services Social Workers and Law Enforcement Officers in the homeless encampment)
- Focus on the Jail Detox Programs

She noted they are looking for other communities that may be interested, if so, she asked them to contact her directly.

Jackie Henderson, Island County, said a hearing took place on Monday with the Oak Harbor City Hearing Examiner for a Conditional Use Permit for the Crisis Detox and Stabilization Facility. The hearing went well, she noted, and the decision will be made within a week or two.

Report from the Advisory Board (AB); Pat-O'Maley Lanphear, Advisory Board Chair

Pat gave the AB Report and covered the following topics:

- Marci Bloomquist from Community Health Plan of Washington (CHPW) attended the AB meeting, she is the first
 of the Managed Care Organizations (MCOs) Representatives to attend the AB Meeting. She is planning on
 attending future AB meetings.
- AB members voted on Karen Mitchell (Whatcom County candidate) becoming part of the Advisory Board, vote was approved unanimously.
- The AB's Pre-Meeting Session time will be used for developing workplans. AB members have asked Health Care Authority (HCA) to attend their meeting in January and Accountable Community of Health (ACH) to attend in February. Information gathered will be used for work-sessions around accountability.
- AB members met with the Governor and discussed topics of concern, to include the funding gap issues.
- AB members received training on "Get Your Ask Out" (learning how to tell your story in 10 minutes or less).
 - o This training will assist members in the Legislative and County Council meetings.
- The Co-Occurring Disorder (COD) Conference was attended by one of the AB members.
- Upcoming Legislative Session Visit dates were discussed. Six members will be attending the session.

Report from the Governance Operations (G&O) Committee

Action Items

For Executive Committee Approval

Summary:

The North Sound Behavioral Health Organization is changing to the North Sound Behavioral Health Administrative Services Organization. To accommodate this, we are requesting to set up a new fund in the Skagit County Auditor and Treasurer's Office to track revenues and expenditures.

Motion #18-130

To create a new fund at the Skagit County Auditor and Treasurer's Office. The name of the fund will be the North Sound Behavioral Health Administrative Services Organization Operating Fund. It will be established January 1, 2019.

Russell Wiita moved the motion for approval, Jackie Henderson seconded, all in favor, motion #18-130 carried

Summary:

Professional Service Contracts

The Accountable Communities of Health (ACH) mid-adopter funds will be used to fund the provider contracts to ensure the provider's electronic health record will meet the requirements for data submission beginning April 1, 2019. XPIO will continue consultation where needed, however, most of the funding will pay for the software/hardware upgrades/modifications. The individual provider funding has not been determined. The motion below gives the Executive Director authority to sign the contracts once the funding is determined.

Motion #18-131

 Authorizing the Executive Director to sign the contracts once funding has been determined for network providers participating in the XPIO consultation and implementation.

Summary:

Projects for Assistance in Transition from Homelessness (PATH)

PATH services are in Snohomish and Whatcom County delivered by Compass Health. This is an outreach program to individuals/families who are homeless, with a special emphasis on Veterans.

Motion #18-132

- HCA-North Sound BHO-PATH-19 is for outreach services in Snohomish County. The maximum consideration on this contract is \$41,816 with the term of the contract October 1, 2018 through December 31, 2018.
- HCA North Sound BHO PATH-19 is for outreach services in Whatcom County. The maximum consideration on this contract is \$12,940 with the term of the contract October 1, 2018 through December 31, 2018.

Ken Dahlstedt moved the motion for approval, Regina Delahunt seconded, all in favor, motion #18-132 carried

Summary:

PATH services are in Snonomish and Whatcom County delivered by Compass Health. This is an outreach program to individuals/families who are homeless, with a special emphasis on Veterans.

Motion #18-133

- North Sound BHO-Compass Health-PATH-Snohomish-18 for outreach services in Snohomish County. The increase in funding is \$41,816 PATH funds, \$13,919 PATH match, \$35,165 additional local funds for a maximum consideration of \$90,900 with the term of the contract October 1, 2018 through December 31, 2018.
- North Sound BHO-Compass Health-PATH-Whatcom-18 for outreach services in Whatcom County. The increase in funding is \$12,532 PATH funds, \$4,313 PATH match, \$15,285 additional local funds for a maximum consideration of \$32,130, with the term of the contract October 1, 2018 through December 31, 2018.

Cammy Hart-Anderson moved the motion for approval, Ken Dahlstedt seconded, all in favor, motion #18-133 carried

Summary:

Snohomish County Behavioral Health Facilities

Snohomish County is requesting \$100,000 more in Medicaid funding to purchase furniture and other essentials for the services that will occur in the Carnegie Resource Center. The original cost estimate was estimated lower than actual costs. The Center will serve veterans, homeless individuals/families, recently released inmates and other persons needing mental health/substance use treatment. Snohomish County will be contributing a 10% match. This contract is being extended through March 31, 2019.

Snohomish County is requesting \$620,000 in Medicaid Funds for the renovations at the Denny Juvenile Center. The Center will be used as a Behavioral Health Treatment Center with two 16-bed units serving adults. The funding will purchase beds, mattresses, storage cabinets, desks, chairs, tables, appliances and other essential furniture, fixtures and equipment needed for start-up. Items will be securely stored by Snohomish County until construction is completed. Snohomish County will be contributing a 10% match.

Motion #18-134

North Sound BHO-Snohomish County-Medicaid-16-18 Amendment 6 to increase the contract by \$720,000 for a new maximum consideration of \$7,466,294 with the term remaining the same April 1, 2016 through March 31, 2019.

Ken Dahlstedt moved the motion for approval, Jackie Henderson seconded, all in favor, motion #18-134 carried

Summary:

6032 Retention/Recruitment-Funds

6032 funds will be distributed to network providers who applied for the retention and recruitment funding. The legislature identified wages as one of the priorities for the 6032 funds. The areas identified are:

- o Workforce/Recruitment and Retention
- o Licensing and certification fees
- Loan repayment assistance

Motion# 18-135

 North Sound BHO-Asian Counseling & Treatment Services (ACTS)-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$117,407 with a term of July 1, 2018 through March 31, 2019.

- North Sound BHO-Bridegeways-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$38,516 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Center for Human Services-PSC-18-19 to provide funding for retention/recruitment strategies
 in the amount of \$334,330 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Catholic Community Services NW-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$722,755 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Compass Health-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$2,090,899 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Ideal Balance-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$34,801 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Sea Mar-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$459,813 with a term of July 1, 2018 through March 31, 2019.
- North Sound BHO-Sunrise Services-PSC-18-19 to provide funding for retention/recruitment strategies in the amount of \$388,661 with a term of July 1, 2018 through March 31, 2019.

Jackie Mitchell moved the motion for approval Jackie Henderson seconded, all in favor, motion #18-135 carried

Summary:

WiSe Expansion

Compass Health has requested a WISe start up budget for the WISe expansion they are currently implementing. The total amount is \$627,000, with \$150,000 in wages and benefits, \$375,000 in supplies, computers, desks, chairs, cell phones and other furnishings and \$102,000 in overhead (15%). The expansion of WISe is in all five (5) counties.

Motion #18-136

North Sound BHO-Compass Health-PSC-18-19 is for WISe expansion startup funds in the amount of \$627,000. The term of the contract is March 1, 2018 through March 31, 2019.

Jackie Mitchell moved the motion for approval, Ken Dahlstedt seconded, all in favor, motion #18-136 carried

Summary:

Skagit County Administration

Skagit County is requesting funds in the amount of \$40,000 for the project oversight, phase II planning and design for the Skagit Stabilization Campus Evaluation and Treatment and Secure Detox facilities. This requires a 9% local match.

Motion #18-137

North Sound BHO-Skagit County Admin-18 Amendment to provide \$40,000 in funding to oversee the development of the Skagit Stabilization Facility planning and design. The new maximum consideration for this agreement is \$980,930.20 with the term remaining the same January 1, 2018 through December 31, 2018.

Jackie Mitchell moved the motion for approval, Regina Delahunt seconded, all in favor, motion #18-137 carried

Informational

- Mental Health Block Grant (MHBG) funding changes for 2019. \$1,023,620 will be allocated toward the crisis system, specifically for Crisis Prevention and Intervention Teams and Crisis Stabilization for Non-Medicaid individuals in our Triage Centers. Additionally, we will continue funding the Tulalip Tribes for at risk youth outreach at \$75,000 annually.
- Substance Abuse Block Grant (SABG) funding changes for 2019. A portion of the SABG funding will be moved from outpatient services to Pregnant and Parenting Women Housing Supports and Therapeutic Intervention for Children.

Margaret Rojas, North Sound BHO Contracts Manager, reviewed the informational items listed above and discussion followed

Summary:

The North Sound BHO is requesting of the CAEC place on the November 8th CAEC Agenda, Motion #18-127 which was removed from the October 11th CAEC Meeting agenda.

Motion #18-141

■ To move Motion #18-127-to the November 8th CAEC Agenda for CAEC action.

Ken Dahlstedt moved the motion for approval, Jackie Mitchell seconded, all in favor, motion #18-41 carried

Summary

As part of our ongoing retention strategies we are asking the CAEC to approve two additional floating holidays to be used at staff discretion. Currently staff have two days available to them, this would provide a total of four days, floating holidays are paid days off. We are requesting the two additional days be available for use on January 1, 2019. This motion excludes the Executive Director position.

Motion #18-127

To provide an additional two days of paid time off as floating holidays, for a maximum of four floating holidays per calendar year with implementation on January 1, 2019.

Regina Delahunt moved the motion for approval, Ken Dahlstedt seconded all in favor, Snohomish County opposed (Russell Wiita, Darcy Cheesman, Cammy Hart-Anderson). Motion #18-127 carried by majority vote
