For Board Approval

North Star Connect – Stronger Together Symposium

Skagit County is seeking funding to support the inaugural North Star Symposium. North Star is a multi-sector collaborative bringing together county and city elected officials, community service providers, healthcare professionals, faith-based communities, and individuals with lived experience to identify more effective ways to respond to homelessness in Skagit Count. This effort aims to improve the behavioral health system and expand the availability of affordable housing. Funding will assist with covering costs associated with venue, food, and symposium speakers.

Motion #25-14

NORTH SOUND BH-ASO-SKAGIT COUNTY-PSC-25 in the amount of \$35,000.00 Mental Health Block Grant (MHBG) Funds for the North Star Symposium. The contract term is April 1, 2025, through June 30, 2025.

Evergreen Recovery Centers – Homeless Outreach Stabilization & Transition (HOST Program)

Evergreen Recovery Centers received start-up funding in July 1, 2024 to expand the HOST Program into Skagit and Island Counties. They have exhausted start-up funds and have requested the ongoing funding for the Skagit Island (SKIL) Host Program. Funding will be prorated through June 30, 2025. Any unspent funds will not roll over.

NORTH SOUND BH-ASO-EVERGREEN RECOVERY CENTERS-ICN-23 AMD 6 in the amount of \$261,000 to provide additional funding for the SKIL HOST Program. Funding will be available through June 30, 2025.

Lifeline Connections – Housing and Recovery through Peer Services (HARPS)

Lifeline Connections receives funding for HARPS subsidies and the HARPS team. Lifeline Connections has fully utilized their HARPS subsidy funding. North Sound BH-ASO has unallocated HARPS funds that Lifeline may utilize through June 30, 2025. Any unspent funds will not roll over.

NS BH-ASO-LIFELINE CONNECTIONS-FGB-23 AMD 7 in the amount of \$50,000 to provide additional HARPS funding through June 30, 2025.

American Rescue Plan ACT (ARPA) Funding – Notice of Suspension

Effective March 24, 2025, the Substance Abuse and Mental Health Services Administration (SAMHSA) terminated multiple COVID-19 pandemic-related grants, including those funded under the American Rescue Plan Act (ARPA) Act. North Sound BH-ASO received notification from Health Care Authority (HCA) on March 27, 2025, suspending funds for activities under our contract, those activities are suspended immediately.

North Sound BH-ASO sent notification on March 28, 2025, to the below downstream contracts that their organization will no longer receive ARPA funding, effective March 24, 2025, for the identified programs/services pursuant to the terms and conditions of their contract. Invoices will be paid through March 24, 2025, any balance remaining on our ARPA grant will be returned to the Health Care Authority.

Center for Human Services

Center for Human Services (CHS) is a Behavioral Health Agency (BHA) that provides youth and family outpatient mental health and Substance Use Disorder (SUD) services in Snohomish County, including in school-based settings. This is a fee for service contract.

NS BH-ASO-CHS-ICN-25 for the provision of outpatient services in Snohomish County. The contract term is March 1, 2025, through December 31, 2025, with an automatic one-year renewal on January 1, 2026, based on compliance with the terms of this contract. Assisted Outpatient Treatment (AOT) Court Services

North Sound BH-ASO has been coordinating with the Snohomish County Prosecutor's Office, the Snohomish County Public Defender Association, and the Snohomish County Clerk's Office to prepare court services associated with Assisted Outpatient Treatment, with a proposed effective date of March 1, 2025. Funding is

- The Snohomish County Prosecuting Attorney's Office will represent the individuals or agencies petitioning for AOT orders in all court proceedings in accordance with RCW 71.05. They will also review AOT petitions for legal sufficiency.
- The Snohomish County Public Defender Association (SCPDA) will represent the individuals being petitioned for AOT orders in all court proceedings in accordance with RCW 71.05. SCPDA will provide a part-time defense attorney and part-time social worker to represent all persons who are not represented by counsel and who are AOT participants.
- The Superior Court Clerk is responsible for processing all court documents relating to AOT including AOT petitions, declarations, orders, petitions for revocation, notices of hearings, and others. They are responsible for keeping minutes of AOT hearings, filing orders entered during court, and entering information into the statewide court system.

Motion #25-11

NS BH-ASO-SNOHOMISH PROSECUTING ATTORNEY-AOT-25 to provide funding in the amount of \$16,543.00 for court services in Snohomish County. This is a 6-month funding allocation. HIGHLIGHTS

- 1. The ratio of Budget to Actuals revenue is good, actual revenues are close to budgeted revenues. Of note we are budgeting for a loss this year due to utilizing fund balances, accounted for in the revenue section as "Use of Fund Balance". Crisis Services billing from Providers are behind, the other negative variances are due mainly to late payments, late billing and reserve balance spend down. Our expenses are currently running \$800,004 over budget making up for January 2025 \$499,244 under budget and February 2025 \$483,994 under budget.
- 2. The Revenue and Expense statement looks good at the end of March, showing a net income of \$1,284,921 mainly due to receiving MHBG and SABG payments for previous months billings MCO retro payments and six-month proviso funds. The MHBG and SABG negative fund balances are due to fluctuations in billing and reimbursement payments from the HCA. Our revenues are covering our expenses. Our general fund balance was \$9,378,882 on 12/31/24 and our maximum allowed is \$6,130,213.
- 3. The Medicaid fund balance has increased slightly as we continue implementing the six-month reconciliation and receiving retro PMPM payments. The MCOs pay at the beginning of the month, however our expenses are not recognized until the following month.

NOTES

- 1. We are presenting the financial statements for February 2025 for North Sound Behavioral Health Administrative Services Organization (ASO).
- 2. These monthly statements are prepared for the Board's use only. They provide a snapshot of expenses and revenue for a single calendar month compared with a hypothetical "year to date" projection. However, neither revenue nor expenditures occur on an equal 1/12 amount each month.
- 4. The North Sound BH-ASO adopts "calendar year" budgets, the funding allocations from the state is a state fiscal year basis [with adjustments every 6 months]. The exceptions are Federal Block Grant Funds which are allocated for the entire fiscal year.
- 5. Revenues and expenses are managed independently within each of the major funds, categories: Medicaid, State General Fund, Mental Health Block Grant, and Substance Abuse Block Grant.

- 6. Within 'State General Funds', allocations are further subdivided between general state funds, and the multiple "Proviso" funds allocated for specific services.
- 7. We have added two new lines at the bottom of the "Revenue and Expense" tab which shows the beginning and ending fund balance within each fund category for the state fiscal year. Also added are additional lines at the bottom to show the Net Income from Operations before the transfer of funds to the BHO.

BHASO Reserve Funds

There has been no update on this issue since last month.

ARPA/COVID SAMHSA Grants:

Health Care Authority (HCA) has received notice from the federal government that ARPA/COVID grants are ended as of 3/24/25. These grants were meant to run through September 2025. While much of our grants had been fully utilized, we have approximately \$1.7 million remaining at North Sound BHASO. Of that \$1.7 million, \$732,888 was in contract with \$534,184 not yet billed.

- North Sound BHASO sent letters to all agencies and affected groups on Friday with agency/program-specific notices. Where we could, we utilized other funds to cover expenses.
- HCA is working to identify full impact and whether Washington State will pursue legal action.
- Normally, towards the end of these types of grants, North Sound BHASO would work to
 utilize remaining funds to cover existing crisis services and spend down the funds. Given
 that these funds would have run until September, we had just started to substitute
 unspent funds for other fund sources within our crisis system. We will not be able to do
 so moving forward.

HB 1813

At this point, the language speaking to Medicaid Reprocurement planning has been removed from HB 1813. It still includes language regarding mandatory delegation of Crisis Relief Centers.

House and Senate Budgets:

The majority of the cuts on the House and Senate Budgets have minimal impact to BHASO budgets statewide. The major question mark is Recovery Navigator Program (RNP).

- Governor's Budget: Recommends 50% cut
- House Budget: Recommends 10% cut, includes language that speaks to BHASOs
 potentially being able to use their reserves to cover the difference, has language that
 indicates some funding would be protected for Snohomish, Skagit, and Pierce County
 programs.
- Senate Budget: Recommends 100% cut of RNP

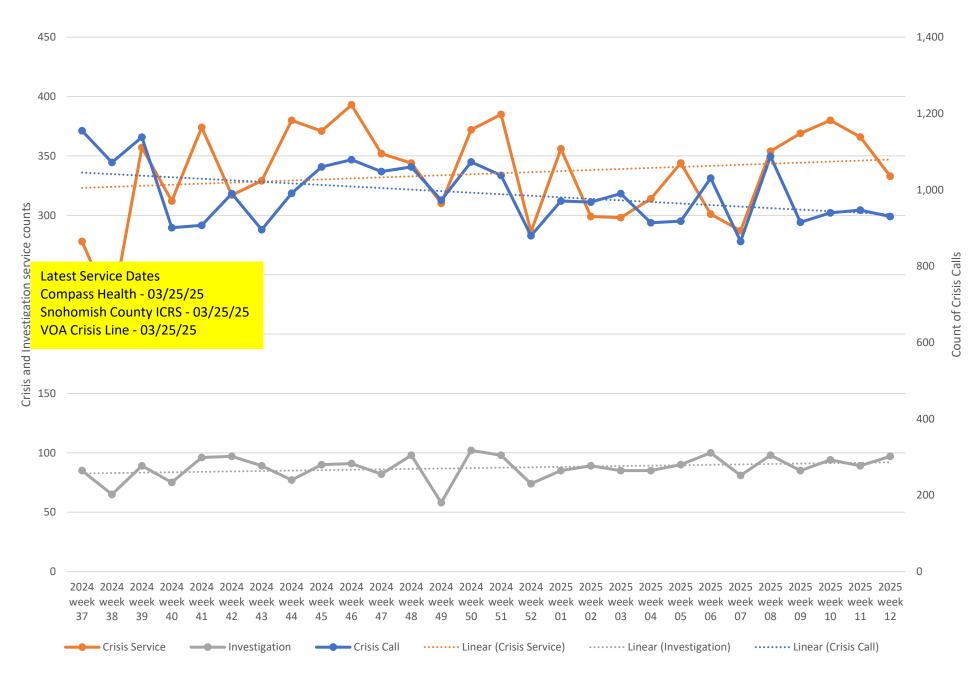
We are presuming there will be cuts to this program but not a 100% cut as the House and Senate work together on their budgets.



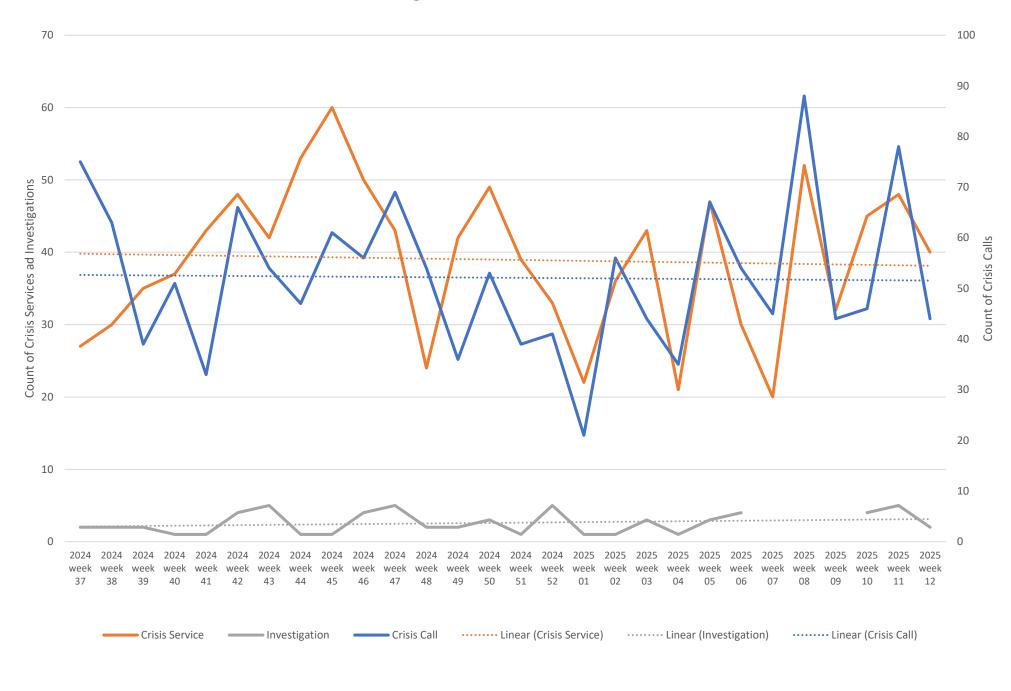

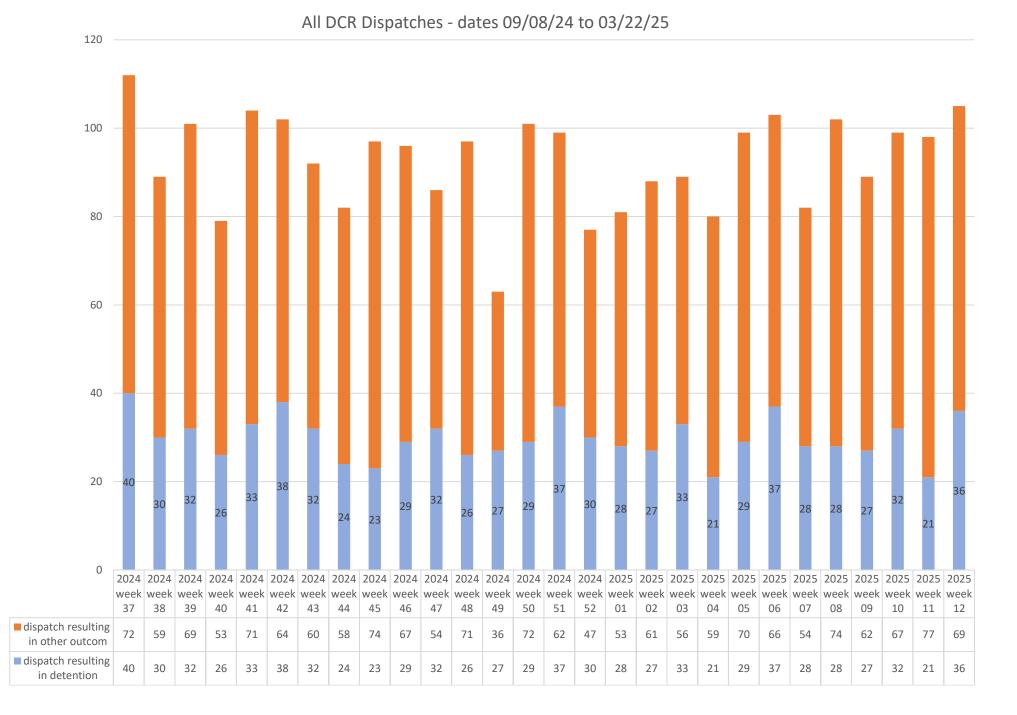

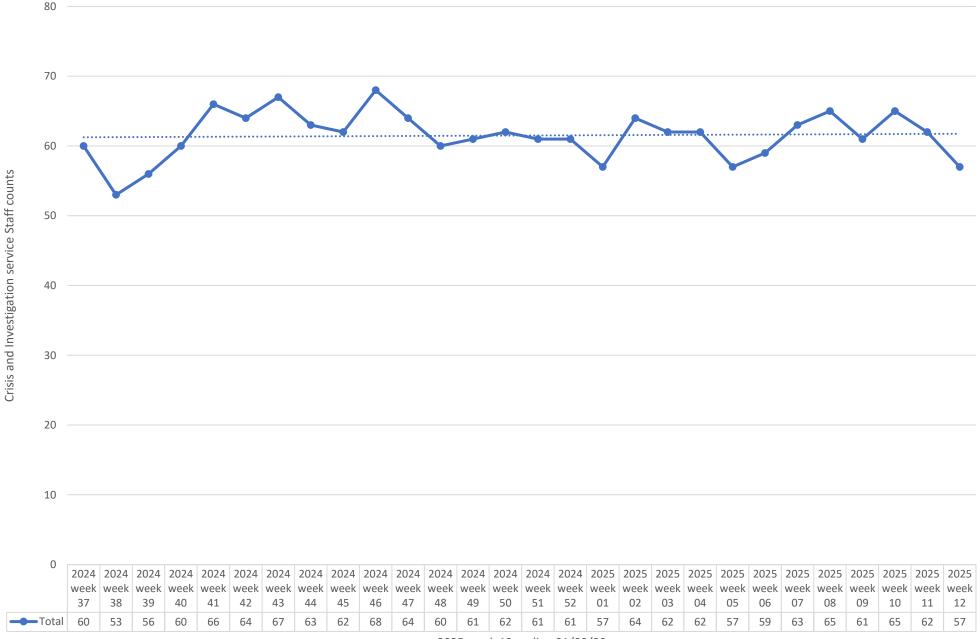

Crisis Data: Ages 0-17 - dates 09/08/24 to 03/22/25



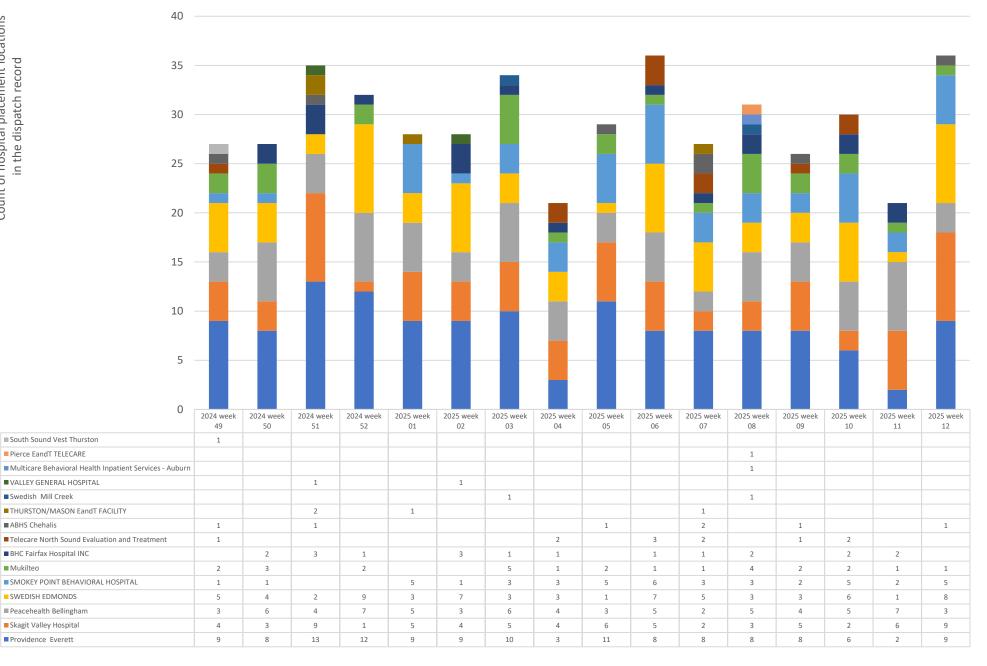




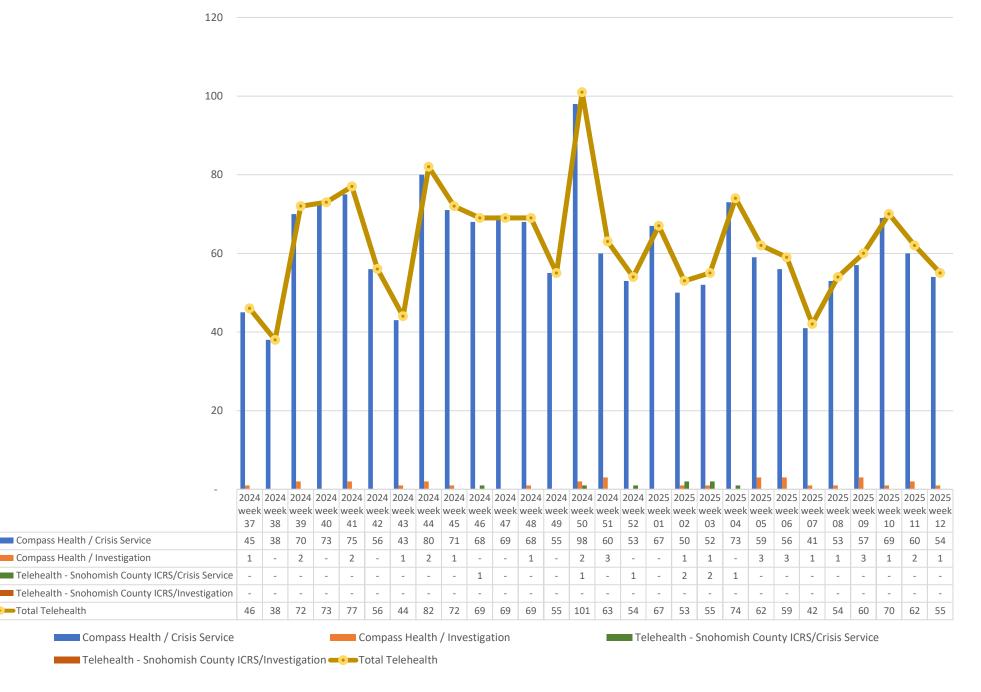

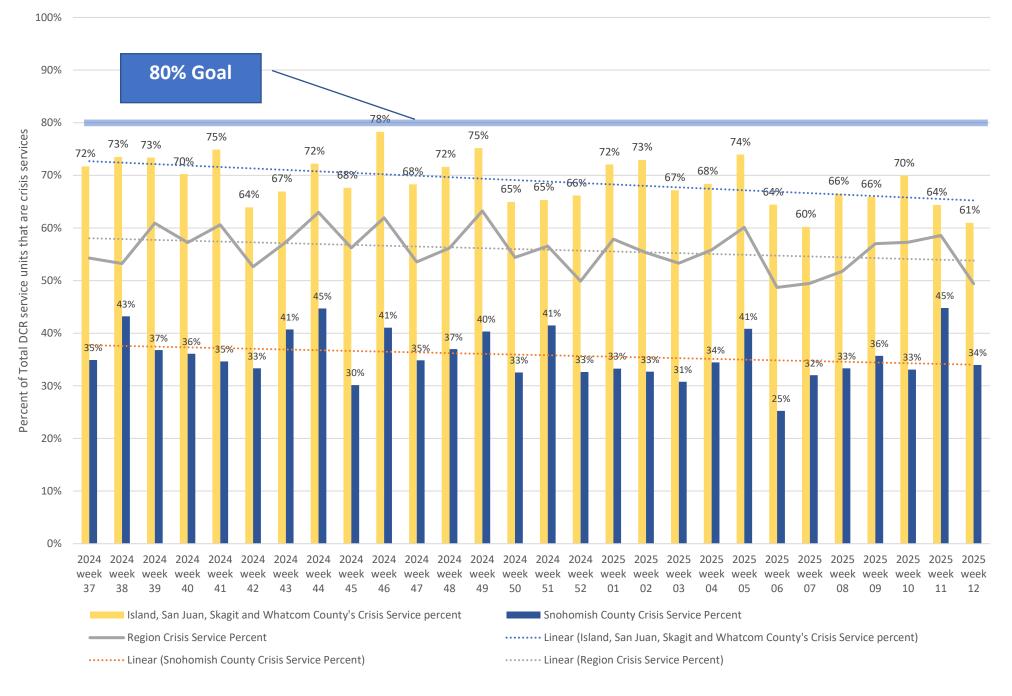
